# Explanation of Classes of Membership

**Governmental (entity and individual):** To be eligible for governmental membership, one must be employed full-time by a unit of state, local, or federal government

- **Entity Membership:** Entitles the entity to designate a certain number of persons depending on the population served to be registered as members. This class, however, allows substitution of any person employed by the entity to attend GFOA conferences at the member (as opposed to the non-member) registration rate. It also allows the entity to register additional members beyond the base number at a reduced fee.
- **Individual Membership:** Registers that individual alone to membership. No other person other than the individual member is entitled to the member rate at GFOA conferences. **The cost of an individual governmental membership is \$25 annually.**

## Commercial (Associate) - corporate and individual:

- **Corporate:** Entitles the entity to designate up to three persons from the firm to be designated as members. This class, however, allows substitution of any person employed by the firm to attend GFOA conferences at the member (as opposed to the non-member) registration rate. **The cost of a corporate membership is \$125 annually.**
- **Individual Membership:** Registers that individual alone to membership. No other person other than the individual member is entitled to the member rate at GFOA conferences. **The cost of an individual associate membership is \$25 annually.**

**Retired Individual:** To be eligible for this membership, one must have retired from a government entity and not be currently employed.

- **The cost of a retiree membership is \$10 annually**

## Governmental Entity Dues (based on population)

Population Served	Base # of Members Allowed	Base Fee
0 - 10,000	1	\$25
10,001 - 25,000	2	\$50
25,001 - 50,000	3	\$75
50,001-100,000	4	\$100
over 100,000	5	\$125

*For each additional member beyond the base number, add \$20 for each.*

EXAMPLE: City X has a population of 30,000, wishes to register as a governmental entity, and wants to name seven employees as members. According to the chart above, they are entitled to three members in their base dues of \$75. The remaining four employees may be registered at a cost of \$20 each (or \$80). Therefore, the total membership dues for the entity is \$155 (\$75 base dues plus \$80 for the four additional members)
